**XIII – Exterior Painting – Revised October 2019**

**Painting Using an Existing Color Scheme:** Whether a homeowner intends to paint her or his entire home with its existing color scheme or merely to touch it up with its existing color scheme the homeowner is not required to seek approval from the Architectural Committee or the Board of Directors (Article VII of the CC&R's). However, the homeowner must provide the Architectural committee with notice of the painting project by describing the area(s) of the house to be painted and by providing paint samples of the color(s) to be used, as well as stating the beginning date and the estimated completion date not to exceed a maximum of 120 days.

**Painting Using a New Color Scheme:** If a homeowner intends to paint her or his home with a color scheme different from the home's existing color scheme the color scheme needs to be approved by the Architectural Committee as to whether the proposed color scheme is in harmony (pleasing) with the color schemes of surrounding homes. (Article VII of the CC&R's). If the Architectural Committee does not approve the color scheme it must give the reasons in writing for its disapproval, and the homeowner may appeal the committee's decision to the entire Board of Directors. Failure to obtain approval from the Architectural Committee or the Board of Directors may result in the application of fines until the color scheme is brought into compliance with these guidelines and the CC&R's.

1. When applying for approval of a new color scheme the homeowner needs to complete a paint application form.
